SECTION I

Brief rules for the submission of the proposal are given below (Also see the specific criteria for nomination in Section II & III):

Rules for nomination of Oration /Awards

1. Any Fellow of the IACP can propose the name of any member of the IACP for the Oration/award. The fellow who is nominating / proposing the member must write his/her name, IACP fellow membership No. with signature.
2. The proposal of any distinguished clinical psychologist may be submitted in the attached format along with the consent of the nominee to the Awards Committee of IACP by **8th February, 2023**.
3. The proposal should contain curriculum vitae of the person proposed for the award with the consent of the person proposed for the award.
4. The Awards Committee shall rate the nominations based on the rules for each award.
5. The nomination securing the highest total points (out of 100) shall be selected for the award, subject to ratification by the Executive Council of the IACP.
6. The oration papers will become the property of the IACP and shall be published in the Indian Journal of Clinical Psychology (IJCP) subject to editorial corrections, if necessary. The awardees shall submit the full paper of the oration to the Editor, IJCP, immediately after the oration at the National Annual Conference for its publication.
7. The awardees may choose any topic for the oration. The awardees shall intimate the title of the oration to the Awards Committee by **8th February 2023**.
8. The awardees shall be presented a scroll/certificate along with a monetary award wherever applicable, as per the terms of the institution of the award.
9. No member shall be conferred the same award a second time.
10. The names proposed for an award, shall not be considered for any other award for that year.

SECTION II

Specific criteria (also see the nomination form)

1. Kang Oration

Criteria

- a. Any distinguished clinical psychologist or a person who has worked relentlessly for the advancement of clinical psychology.
- b. Willing to deliver Kang Memorial Oration at the Annual conference of IACP for which the awardee is chosen.

2. H N Murthy Oration

Criteria

- a. Any distinguished clinical psychologist or a person who has worked relentlessly for the advancement of Behavior Therapy/Cognitive Behavior Therapy.
- b. Willing to deliver H.N. Murthy Oration at the Annual conference of IACP for which the awardee is chosen.

3. Psycho award

Criteria

- a. Any distinguished clinical psychologist for any outstanding work done in the area of psycho-diagnostics and psychotherapy.
- b. Willing to deliver Psycho Oration at the Annual conference of IACP for which the awardee is chosen.

4. IACP Child and Adolescent Mental Health award

Criteria

- a. Any distinguished Clinical Psychologist for any other outstanding work done in the area of Child Clinical Psychology.
- b. Willing to deliver IACP Child Development and Mental Health award at the Annual conference of IACP for which the awardee is chosen.

5. S. L. Vaya Forensic Psychology Award

This award has citation only (no oration).

Criteria

- a. Psychologists/ Clinical Psychologists working in forensic laboratories, prisons, in India.

- b. Psychologists/ Clinical Psychologists whose prime area of work/research is related to children or adolescents or adults who are in conflict with law.
- c. Psychologists/ Clinical Psychologists working with police force in any state in India.
- d. Any member (including associate member) of IACP.

Form for submitting nominations is enclosed below for nominating someone whom you consider deserving for the appropriate award.

SECTION III

Rules for Awards that require submission of papers and presentations:

S. C. Gupta Best Paper Award

1. Five copies of the full paper, enclosed with the abstracts along with the information about the author written in separate sheet, shall be submitted to the Awards Committee of IACP.
2. To be eligible for the award, the paper must fulfill each of the following criteria:
 - a. It must be a research paper based on work done in India.
 - b. It must not have been published in a scientific Journal or had received any other award.
 - c. The First author shall be an IACP member and at least 50% of all authors must be members of the IACP at the time of the proposal.
 - d. The author presenting the paper must be a member of the Association at the time of the proposal.

The first author has to mention that the paper is for S C Gupta Award to be included in the competition. Only three papers will be included for the competition after initial evaluation.

Those papers which are not selected for the competition shall be considered for the general category. Authors must mention their Membership No. of IACP. Those competing should give an under taking to be present at the Conference. The name of the awardees will be announced at the conference.
